Principal proposed that the application of Dr Madhuchhanda Lahiri for Ph D incremental benefit be itemized. The House unanimously agreed to itemize the agenda as Item No. 10.

- 1) The proceedings of the last meeting held on 19/04/17 were read and confirmed.
- 2) The Principal placed the Letter No. 1518/Geography/WBSU/Recom/CSC/17, dated 18.5.17 issued by the West Bengal College Service Commission recommending Sri Chandan Sarkar for appointment to the post of Assistant Professor of Geography. The House unanimously accepted and approved the same and requested the Principal to issue the letter of appointment to Sri Chandan Sarkar at the earliest.
- 3) Principal reported that Sri Suraj Kumar Hela, who was appointed as Karmabandhu and wished to join on 5th June, 2017 did not submit his joining report. She further reported that Sri Hela did not report after 5th June. The President, Smt. Manju Basu, took the chair and declared the meeting open.

Sri Suman Ranjan Bandyopadhyay proposed the inclusion of the agenda, "Consideration of the applications of Dr. Mohasin Mallick, Dr. Thakurdas Tudu and Dr. Ajit Das for additional increments" as a table agenda. The house unanimously accepted the proposal and resolved to itemize the same as Item No. 22.

1. The minutes of the previous meeting of the Governing Body held on 20.08.2016 were read and confirmed.
2. The Principal shared the report of the NAAC Peer Team with the members. She also informed the house that the house was accredited with Grade "B" by the NAAC. She stated that it was a grand success under the present circumstances and thanked all the stake holders for the support and active co-operation extended by them without which the college could not have secured the grade. She stated further that though the letter of certification was received the formal certificate was yet to arrive and application for RUSA grant can be processed on receipt of the said certificate. She also said that she would pursue the matter with the concerned authorities in due course. Dr. Mohasin Mallik appraised the house that the U/c for NAAC Peer Team Visit has been sent by post to the concerned office. In the end, the house expressed immense satisfaction at the fact that the college could secure such a high grade and applauded the role played by and the untiring efforts of the Principal, the teaching and the non-teaching staff.
3. The Principal reported that the relevant order pertaining to the appointment of Cashier by promotion was received and urged upon the house to constitute a Selection Committee for the same. The house then unanimously resolved to constitute the following Selection Committee: (i) Dr. Sharmila De, Principal (Chairperson); (ii) Dr. R.K. Sarkar(Member,GB); (iii) Sri Kajal Chanda(Member,GB); (iv) Prof. Sefali Vidyanta(Member,GB); (v) Prof. Sajal Brahmachari(Member,GB); (vi) Dr. Chittaranjan Das (Dinabandhu Mahavidyalaya, Bongaon) and (vii) Dr. Saroj Kumar Chattopadhyay (Principal, Chandraketurgh Sahidullah Smriti Mahavidyalaya).
4. The Principal reported that all the posts sanctioned vide memo. No. 686-Edn (CS) /SE-58/2015 dated 02.08.2016 viz. Clerk (LD), Lab. Attendant, Electrician-cum-Caretaker and 2 Karmabandhus were under the unreserved category.
5. The Principal requested the house to constitute a Selection Committee for the appointment of 5 posts sanctioned vide memo. No. 686-Edn (CS) /SE-58/2015 dated 02.08.2016. The House then unanimously resolved to constitute the following committee: (i) Dr. Sharmila De, Principal (Chairperson); (ii) Dr. R.K. Sarkar(Member,GB); (iii) Sri Kajal Chanda(Member,GB); (iv) Prof. Sefali Vidyanta(Member,GB); (v) Prof. Sajal Brahmachari(Member,GB); (vi) Dr. Chittaranjan Das (Dinabandhu Mahavidyalaya, Bongaon) and (vii) Dr. Dibyendu Talapatra (Principal, Derozio College).
6. The Principal reported that the term of lease for the pond in the college campus had expired and opined that intensive beautification drive should be undertaken to give the college a facelift and the pond should not be given out on lease any further. The house unanimously resolved to accept the proposal of the Principal and decided not to lease out the said pond any further. Thereafter the Principal reported that a newly established illegal perishable market has come up at the front of the college compound on the southern side of the pond and a huge quantity of waste materials was being dumped in the pond causing serious ecological hazards. The house took serious note of the same and advised the Principal to take immediate steps to stop such pollution of the college campus.

7. The Principal placed the letter of Prof. Amal Kumar Bhakat tendering his resignation to the post of Co-ordinator, IQAC, P.N. Das College. The house unanimously resolved to accept the same.

8. The Principal placed the letter of Dr. Ajit Das resigning from the post of Programme Officer, NSS Unit, P.N. Das College. The house unanimously resolved to accept the said resignation.

9. The Principal reported that the Academic Committee of the college had placed a recommendation regarding the constitution of the next committee of the IQAC of the college since the re-constitution of the IQAC was overdue. The house unanimously resolved to accept the recommendation of the Academic Committee and constitute the IQAC comprising the following members: (i) Dr. Sharmila De, Principal (Chairperson), (ii) Dr. Basumita Tarafdar (Co-ordinator), (iii) Prof. Sanjib Kumar Dhar (Member), (iv) Prof. Suman Ranjan Bandyopadhyay (Member), (v) Prof. Kakoli Sen Banerjee, (vi) Prof. Dipa Chakraborty (Member), (vii) Prof. Bablu Biswas (Member), (viii) Dr. Madhuchhanda Lahiri (Member), (ix) Smt. 10. The Principal proposed the name of Prof. Bablu Biswas as Programme Officer, NSS Unit, P.N. Das College. The house unanimously resolved to appoint Sri Biswas as Programme Officer.

11. The Principal informed the house that she had already formed the Equal Opportunity Cell of the college comprising Prof. Ajay Kumar Choudhary (Advisor), Prof. Kakoli Sen Banerjee and Prof. Thakurdas Tudu under the exigency of the situation. She sought the approval of the house regarding the action taken by her in this regard. The house unanimously resolved to approve the action taken by the Principal.

12. The Principal reported that there was no record available with the college to ascertain the exact age of Sri Sunil Dutta, Physical Instructor. Furthermore, despite repeated reminders the incumbent was not submitting any document authenticating his age. She also opined that he did not appear to be physically fit to carry out the job of the physical instructor, especially one who can also double up as the multi-gym instructor, which demands the appointment of a much younger and relatively fit person. The house expressed agreement with the views of the Principal and unanimously resolved to terminate the services of Sri Sunil Dutta w.e.f. 01.12.2016. The Principal was empowered to select a new Physical Instructor at the earliest.

13. The Principal reported that the Festival Advance equal to the amounts of the previous (with the exception of the PTTs for whom the said advance was enhanced to Rs. 8,000/-) had been disbursed before the commencement of the Puja Vacation. She requested the house to approve the steps taken by her in this regard. The house unanimously resolved to approve the action of the Principal.

The convenor, Dr. S. Bhattacharya proposed the name of the Principal, Dr. S. Dey to preside over the meeting which was seconded by Prof. S. Bandyopadhyay.

Agenda No. 1:-

The convenor informed the House that there has been no past record of any complaint lodged with the ICC.

The external member, Advocate, Sri Anjan Bhattacharya queried whether this shows a lack of knowledge about the existence of the committee. But the Principal informed that the existence of the committee has been posted on the college website, but more visual demonstration needed to be done in the form of posters, flexes etc. The Advocate proposed that complaint should be in written form and confidentiality ensured.

The above member also laid stress on the sub-heading (b)..." publicly notify the provisions against sexual harassment and ensure their wide dissemination;" of item no. 3 of UGC notification... (Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulations, 2015.

He further proposed that an elaborate description of the functions of the committee be done in the Prospectus, along with a detailed report on the website. He further proposed a zero-tolerance policy towards sexual harassment.

The Principal proposed that half-yearly reports be furnished by the committee each year. Further, any form of gender discrimination will come under the purview of the ICC and so Gender Sensitisation programme is to be carried out.

Next, Advocate, Sri Bhattacharya proposed that students' representatives may not necessarily be taken from some elected student body (like student

union),but may also be taken from NCC,NSS etc.Also,half of the members must be women.

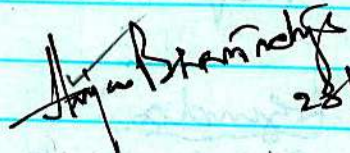

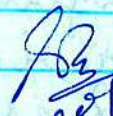

The college is committed to zero tolerance policy towards sexual harassment.Our aim is to create a campus,free from discrimination,harassment ,retaliation or sexual assault at all levels.

We are further committed to provide assistance and all forms of required cooperation and safeguards if an aggrieved person chooses to file complaint with the police.

While the offender will be dealt with punishment according to the college rules,the survivor or victim will be entitled to compensation recommended by the ICC.
